Illinois joins Missouri for State Convention in St. Louis

AAUW-IL 89<sup>th</sup> Convention Friday – Sunday May 3, 4 & 5, 2013 Hilton St. Louis at the Ballpark, St. Louis, MO

## THIS IS SOMETHING YOU WON'T WANT TO MISS!

Our two states are joining to put on a GREAT convention themed "AAUW in Action! **IL**luminating and **MO**tivating Together!" We will meet at the Hilton St. Louis at the Ballpark in St. Louis, MO, with AAUW Executive Director Linda Hallman opening the convention on Saturday morning. Linda will also host the final session, including a Town Hall meeting, on Sunday morning.

At lunch on Saturday we will hear from Cathy Pieronek, the Director of the Women's Engineering Program at Notre Dame University on the topic of Title IX and STEM. There will be eight breakout sessions during the day Saturday with a range of topics (**refer to the <u>schedule</u> on page 12 of this newsletter**) as well as our State Business Meeting. Following Missouri's tradition, we will gather for a banquet on Saturday night featuring an LAF Plaintiff speaking about her military sexual assault case.

Sunday morning brings a unique opportunity for a "Cubs vs. Cardinals" Eleanor Roosevelt Walk/Run around Busch Stadium, which is across the street from the hotel. Wear your favorite team colors – if you don't want to be a Cub (blue), the Cardinals will welcome you on the red team!! ## Luncheon Keynoter – Cathy Pieronek



Cathy Pieronek comes to us from the Society of Women Engineers. She is Assistant Dean for Academic Affairs and Director of the Women's Engineering Program at the University of Notre Dame College of Engineering. Holding a BS (University of Notre Dame) and MS (UCLA) in Aerospace Engineering and a Juris Doctorate from Notre Dame, Cathy is able to address issues of gender equity and Title IX in engineering education. Cathy will also do a breakout session going more deeply into current statistics and analysis of the state of women in STEM today. Among her credentials are having been an engineer with NASA, appearances on a number of television shows on the Title IX issue and long-time memberships in the American Society for Engineering Education and Society of Women Engineers.

## AAUW Executive Director and CEO – Linda D. Hallman

Linda will be opening the convention on Saturday morning and also will be hosting the final session, including a Town Hall meeting, on Sunday morning. As the executive director and CEO of AAUW, Linda is a nationally respected leader with more than 20 years of executive-level experience. Now in her fourth year at the helm of our organization, Hallman has guided AAUW through the financial recession and has increased its levels of funding to meet an ever-growing need. Under her leadership, AAUW ramped up its fellowships and grants program by an extra half-million dollars annually, allowing the organization to continue its primary commitment to break through barriers for women and girls at a time when many women have flocked back to graduate school because of the dismal job market.



Other highlights of Hallman's extensive nonprofit experience include leadership positions with the National Alliance for Health Information Technology, the American Medical Women's Association, the American Horticultural Society, and the American College of Health Care Administrators. Hallman also served in the U.S. Army as a soprano soloist with the U.S. Army Band and Chorus for nine years. Today, Hallman lives with her husband in Washington, D.C., where she maintains a personal commitment to what close friends call her "exquisite" garden.

## What is the AAUW Legacy Circle?

The Legacy Circle is the instrument AAUW uses to recognize and honor those members and individuals who have provided for AAUW in their estate plans. Planned gifts generate a legacy of opportunities to ensure that the work of AAUW continues into the future.

The simplest form of a legacy is a bequest, or a gift left to a charity in your will. There is no minimum amount required to join the AAUW's Legacy Circle; in fact AAUW does not require you to provide an exact figure or estate plans when you join. All you need to do is inform Catherine Heffernan (see below) of AAUW that there is a planned gift for AAUW in your will or living trust.

You can also name AAUW as a beneficiary of your life insurance, bank account, stock amount, or retirement plan. In addition to bequests in your will or living trust, charitable gift annuities are available that can provide you with tax savings and income during your lifetime.

To honor you as a Legacy Circle member, you will receive the exclusively designed AAUW Legacy Circle pin. Given as a gift to Legacy Circle members, the Legacy Circle pin is a meaningful symbol of your generosity and commitment to the future of women and girls. Designed by Swarovski, the pin is a gold wreath adorned with pave crystals and trimmed with a gold ribbon that proudly proclaims, "A Legacy of Equity." At the base of the wreath is an open book with a suspended pearl.

## Membership Matters Rachel Campbell and Margaret Stewart Membership Co-Vice Presidents

Margaret writes: As March slips into April we think "spring." And it's a good time to take stock of where we are in membership recruitment and where we want to go.

Your membership chair and committee may be in the middle of planning a big recruitment event right now. They have probably consulted the Starter Kit, as well as the AAUW website in their planning. But here's a note to all branch members: This is a special time when you as a branch member actually become the membership committee. The membership chair will be counting on you to support this effort, especially in bringing your friends and/or prospective members to the event.

This time of year also brings a once-a-year deal in dues. Any dues paid after March 15 by a new member entitle that person to membership not only for this year but also for the 2013-14 year. Still another seasonal perk is Give a Grad a Gift. If you know someone who in the last twenty-four months has completed an Associate's degree or higher, you may present her with a free year's membership in the Association. Some state organizations and branches accept this free membership as well.

This is also a good time to talk about what the branch can do better in membership recruitment. As you look over what you planned to do, what were your successes? What can you do better? Was the branch able to pull off the big events designed to recruit members? If so, terrific! If not, if the branch was disappointed in it, now is the time to talk it over and try to figure out what to do next time – either to make it work or to try something else instead.

As you reflect on your recruitment efforts, keep in mind that more and more people are using the Internet to find the information they want. If you don't have a website, use AAUW resources to help you create one. If you do have a website, keep it fresh and appealing to the potential member looking for a branch.

Finally, there is another membership concern that branch members need to pay attention to. Are you retaining new members or are they dropping out? Are there members who have talents that are not being appreciated? Board members or Interest Group chairs might be able to find a niche for that individual. Do all members feel comfortable when they come to meetings? Everyone can help to make the event a good experience for all.

In assessing the year's activities, the membership chair will get the conversation going and the membership committee will help. But the biggest successes will come only if every branch member gets involved.

**Public Policy** Marcia Wherry & Diane Balin Public Policy Co-Directors





HATS OFF to our branch public policy people and coalition leaders who organized and carried out so many activities for the 2012 Get Out The Vote (GOTV) campaign. As a result of their hard work, AAUW-IL was recognized as the **national leader** in voter registration and turnout efforts for the fifteen states receiving AAUW Public Policy impact grant monies for 2010 - 2012.

A Special thanks goes to Elgin's **Nicki Skogfeldt** as Campaign Manager and **Laurel Bault** as Coalition Outreach Coordinator from the Elgin Area League of Women Voters for their extraordinary efforts for GOTV activities throughout the northwest Metro area. The coalition with branch members in Cook and the collar counties and northern branches such as Rockford were responsible for the lion's share of the state's 4,000+ voter registrations.

Briana Brown was hired by the national office as a part-time campaign organizer during the last four months of the campaign. Briana was responsible for collecting statistics from branches and for promoting participation in voter registration drives, canvassing, and phone banking. Her efforts with voter turnout helped us reach a record 93 campaign activities. Thank you, **Briana Brown**.

Throughout the state, we emphasized registration of women in the millennial generation and the use of social media (including Facebook and Twitter) to reach more potential voters. Branches with members volunteering at registration drives at high schools and colleges included Alton, Arlington Heights, Batavia-Geneva-St Charles, Belleville, Carbondale, Crystal Lake, Elgin, Elmhurst, Hinsdale-Oakbrook, Lombard, Monmouth, Naperville, Quincy, Rockford, Schaumburg, Springfield, Waukegan, Wheaton-Glen Ellyn, and Wood River. GOTV activities following the registration drives included candidate and issue forums organized by Carbondale, Champaign, Decatur, Rockford, and Springfield. Canvassing and phone banking were done by branch members and coalition women from Carbondale, Chicago Inc, Downers Grove, Elgin, and Riverside. An Op-Ed column written by Carli Alvarado, a Monmouth College sophomore, and Erika Solberg, adjunct professor at Monmouth College and AAUW member, was published in several newspapers in late October. Their catchy title "Young Women, grab the power. Vote." summarizes the efforts for the GOTV campaign. On election night AAUW also co-sponsored the streaming of online analysis of election results by statewide commentators.

AAUW members also publicized a successful campaign that urged voters to say NO to Constitutional Amendment #49. This proposal would have had a negative impact on many public employee pensions. In follow-up to the fall elections, we reviewed statistics relating to participation in state-wide elections. The following information from the State Board of Elections provides a comparison of registrations and turnout for primary and general elections during the past 12 years. Note the fluctuations during years of presidential elections versus years of state-wide elections. There is more work to do with turnout in the future!

#### New Tracking System for Pending State Legislation

The national office is providing access for states to use the CQ State Track System to track the status of state bills that are identified by key words such as education, sexual health education, and pension reform. We are using this system to supplement a similar system used by our lobbyist, Jenni Purdue. As the legislative session progresses, reviews of the systems will help us alert AAUW members about contacting their legislators concerning action on state bills. This activity supplements the AAUW Action Fund (www.aauwaction.org), Washington Update, and the Two Minute Activist alerts that come via email from National. National alerts provide information and may ask members to send a message to your congressman on certain issues.

AAUW's mission is to advance equity for women and girls. While the efforts in the USA have produced results, some of our foreign sisters and daughters are legions behind our efforts. The pervasive, disturbing and apparently culturally-oppressive conditions for women and girls in some countries are unsettling at best. With our mission statement to support us, and the obvious need ahead of us, we are empowered to compel changes.

Our organization is affiliated with the United Nations, <u>Women Thrive Worldwide</u>, <u>7 Billion Actions</u>, C.A.R.E. and the Virginia Gildersleeve Foundation. These organizations are a click away. Most welcome donations. AAUW Funds also provides international post-graduate scholarships for women from other countries. Anecdotally, many fellow AAUW members contribute to smaller micro-financing efforts for women and families. Researching organizations before sending money is always wise, since much has been written lately about 'misdirected' funds. You may want to make sure that the organization's purpose and your purpose are related if not identical.

Our voices can generate more awareness and visibility. Our legislators need to know our concerns. Many events have been highlighted by media investigations. In some cases, foreign government officials haven't the grace to be embarrassed. Continuing to focus light on world affairs may increase political action within these countries.

I have been keeping my eyes and ears open for local hands-on groups that develop projects in foreign communities. These groups handle a project's funds locally. Thus, they are removing the temptation for asset mismanagement. The projects are closely monitored and successes, while seemingly modest, are gratifying. I have found several such groups in northern Illinois. Of course, these are like drips of water on a parched field when a good soaking rain is needed. Many tiny projects along with consistent long-term help by larger NGO's and Foreign Government Aid may eventually turn the tide.

We cannot experience the unique situations, politics and injustices occurring around the world. In <u>HALF THE</u> <u>SKY</u> by Kristof & WuDunn, one is struck by the many different and awful ways that women continue to suffer. You are empowered to change the dynamic—one family at a time. ## Fun Things to do in St. Louis

Two pre-convention trips are planned for Friday afternoon. You may choose to take a free tour of the newly renovated Central Library, a downtown St. Louis landmark, or you may prefer to take a one-hour riverboat ride for \$14, which leaves from under The Gateway Arch just a few blocks from the hotel. Those interested in the second option will leave from the hotel lobby at 2 PM for a 3 PM boat ride. The Gateway Arch, our nation's tallest monument, is a must-see. Many other options exist for those who enjoy venturing out on their own, including the Missouri Botanical Garden and the St. Louis City Museum. Both of these are free and FABULOUS!



Friday night options include a fantastic rooftop bar called 360, right at the top of our hotel, where views include The Gateway Arch, Busch Stadium and the Mississippi River. There is a great music area on Broadway just south of the hotel, and the Lumiere Place Casino is also nearby.
