### **AAUW CEO Kimberly Churches to attend convention on Friday!**



AAUW-IL is very pleased to announce **Kimberly Churches will be our honored guest and keynote speaker on Friday evening.** Kim has said she uses three words every day: focus, relevance, and impact. AAUW's new strategic plan clearly reflects her mantra and her leadership. The plan focuses on 3 key issues where AAUW is uniquely positioned to lead and make a lasting impact: education and training, economic security, and leadership. It prioritizes economic security and pay equity with the goal to close the gender pay gap by 2030 and includes a major effort to train 10 million women in salary negotiations by 2022. The plan provides a path forward, and ensures AAUW will be distinct, relevant, and vital in the future. Kim Churches is a compelling spokeswoman for "Beyond Aspirations: Advancing Equity for Women & Girls." Plan to join us for dinner, her program, and a special reception to celebrate Kim's leadership!

Kimberly Churches became the chief executive officer of the American Association of University Women (AAUW) on June 1, 2017. Prior to joining AAUW, Kim served as the managing director of the Brookings Institution, an internationally recognized public policy think tank. She has also served as an associate vice chancellor at the University of Denver, a director of development at the University of North Florida, and a division director at the American Heart Association. She has extensive experience working collaboratively on education (K-12 and higher education) as well as capacity building among grassroots groups and national and international nonprofits. Churches earned her BA at Florida State University in English Education and the Certified Fund Raising Executive affiliation in 2002. Kim lives in the District with her daughter and is a devoted Washington Nationals fan.

### Saturday Keynote Speaker Betsy Dirksen Londrigan



Betsy Dirksen Londrigan is a Springfield native, a professional fundraiser, a longtime Democrat, and a recent first-time candidate for elected political office. In 2018 Londrigan ran for Congress in Illinois's 13<sup>th</sup> congressional district against third-term Republican, Rodney Davis. She was inspired to pursue the seat because of the attempt in Congress to repeal the ACA, a deeply personal issue for her. In 2009, Londrigan's 12-year-old son spent 24 days in pediatric ICU from a tick bite. He recovered, and good health insurance saved her family from bankruptcy. She focused on access to affordable health care and coverage for pre-existing conditions in her campaign. She was well-informed on key issues and held town halls in each of the 14 counties in her district. She spent 16 months and put 60,000 miles on her car traveling to

meet and listen to people in her district. Londrigan finished the race with 134,458 votes (49.6%) to Davis's 136,516 votes (50.4%). Betsy has said she is proud of the race "we" ran. It was hard-fought, issue-focused, and meaningful. Promises were made that need to be kept. And the movement and team effort we created is only going to get stronger. Londrigan earned a BA in rhetoric and composition, and a BS in political science at the University of Illinois (U-C) in 1993. She taught middle school English for Teach for America in Baltimore, MD. She was hired as the first Alumni Affairs Director for UIS, and worked as the Development Officer for the Abraham Lincoln Presidential Library Foundation.

# Zoe Spencer AAUW Legal Advocacy Fund Plaintiff



Dr. Zoe Spencer is originally from Barry Farms projects in Washington, D.C. As a single mom, she sacrificed and struggled to raise a son while working and pursuing her education. Spencer is an associate professor of sociology at Virginia State University with a Ph.D. from Howard University. As the Gender Equity Task Force chair at VSU, she identified deficits in gender equity, spoke out against them, and met with resistance. Two male administrators appointed to her rank were less qualified, had less experience, and were assigned to teach fewer courses with lower student loads. Yet their salaries were

significantly higher than those of female professors at all ranks. Spencer requested a salary adjustment based on Title VII and EPA, but her request was denied. Spencer alleges she subsequently faced retaliation, including delays in processing her pay. Her advocacy for reform prompted litigation claiming wage discrimination and retaliation. The Legal Advocacy Fund adopted Spencer's case, "Spencer v. Virginia State University," in 2017.

# Deanie Brown Title IX Updates



U.S. Secretary of Education Betsy DeVos's proposed amendments to Title IX would erode the Obama administration's guidance on sexual harassment and roll back protections for sexual assault victims. Her regulations reduce schools' responsibilities to enforce Title IX complaints, give the accused more rights and protection, and make it harder for victims to report sexual harassment and assault. If passed, the new rules would harm student victims and undermine the purpose of Title IX. These changes have been widely scrutinized, and in many cases criticized, by over 100,000 commenters — including AAUW's national leadership. Deanie Brown is an attorney who serves as Associate Chancellor for Access & Equal Opportunity at the University of Illinois Springfield where she oversees campus compliance with their nondiscrimination and human rights policies. Since 2008, Deanie has served UIS as Title IX Coordinator. She

earned her law degree, Juris Doctorate, from the University of Illinois Urbana-Champaign. Deanie is proud to be a member of AAUW, including her current role as co-president, along with Marcia Wherry, of the state's largest branch – Springfield. She has also served as the College and University Relations Director for her branch and for AAUW-IL.

## Media and Information Literacy Natasha Casey



Natasha Casey's favorite class to teach is media and information literacy. The recent national spotlight on "fake news" has provided an opportunity to emphasize the importance of media, information, and news literacy – not just for students, but for all of us. Media and information literacy isn't about "finger-wagging" (Teach these kids to stay off twitter!) or about giving students "golden nuggets" in a lecture. It provides the skills, knowledge, and critical thinking methods to be reflective in the use of media and information. Natasha Casey is an associate professor of communications at Blackburn College in Carlinville, IL.

She teaches a variety or courses including media and information literacy, communication theory, and senior seminar. Natasha received her BA in media studies from the University for the Creative Arts (England) and a M.Sc. in media studies from Texas Christian University (Fort Worth, TX). She holds a PhD in communication studies from McGill University (Montreal, Canada). Her research interests include media and information literacy and critical race theory. She is a member of the National Association for Media Literacy Education. Her website features a blog, "No Silos."

### How to maximize your charitable gifts to AAUW Funds

Here is an idea for those folks that hold a Traditional or SEP IRA. If you are over 70½, you must take a required minimum distribution which is normally taxed as accountholder income in the year received and is reported to the accountholder on a 1099R. You can elect to make a donation to a qualified charity out of your personal IRA and the amount will not be included in your income for the year. There are a couple of caveats, though. The check must be made directly from the IRA account to the charity (the check would bear the logo of the bank or financial service company.) Also, the accountholder should retain the acknowledgement of the donation for audit purposes. Taxpayers report the receipt of the IRA distribution and the donation on their individual tax returns.

Because the tax laws have changed, more people are not itemizing deductions because the standard deduction has increased. Follow me here—if your personal donation is not used because the standard deduction is so high—why not approach this another way. Let me remind you that AAUW-IL Gender Equity Fund and most of the AAUW Funds are charities (verifiable 501 c3's).

If you have appreciated stock in your non-IRA portfolio, you can gift the shares to a qualified charity (AAUW FUNDS.) If you have held these stocks for over a year, you would use their fair market value (the stock price on the day the transfer is made) as an itemized deduction on your personal return. On the other hand, if you sold the stock and gave the proceeds to the charity, you would most likely owe capital gains tax. Don't expect to make this happen on December 31—see your financial service representative a couple weeks before the transfer is to be made—this process is frequently done but it does take paperwork and time.

There are other assets that can be transferred to charities but are somewhat more complicated. Real Estate is another technique. Some charities will accept the asset and retain or sell it. For example, if your local Y is building a new building—the planners may love the location of your undeveloped land and accept the property. If they don't love the property and sell it, the entire proceeds go to the charity. The donor gets a nice itemized deduction.

Collectibles, such as art and jewelry, are a little more involved—you should surely contact your tax planner if you are considering this method. Certified appraisals will be needed, and some assets are so unique their value is hard to determine.

More formal arrangements are sometimes used, such as annuities with the charity as the beneficiary or Charitable Remainder or Charitable Lead Trusts, but believe me, they are more labor intensive. Anyone considering these methods should run it by their tax preparer and maybe their family attorney to make sure it is legal and IS tax advantaged. Although, I worked in this area, I have been gone awhile and things change quickly. The newest and best information is from your own accountant or attorney. Remember, too, that AAUW has an entire department dedicated to "Development," meaning "Donations." They would love to answer your questions if you need to ask for advice.



Plans are underway for AAUW members, along with other women's advocacy groups, to meet in **Springfield** at the **Capitol on MAY 15th** to advocate for equity for women and girls. Mark your calendar now!

SPRINGFIELD DAY will begin around 10 am with AAUW-IL's legislative consultant, Jenni Perdue, educating attendees on the Illinois State legislative process. Attendees will also learn the "lay of the land" before heading out to meet with representatives. Armed with talking points and leaving behind materials regarding Public Policy issues that are important to AAUW, our message to our legislators will be on point and consistent. Depending on the legislative session that is happening on May 15th, AAUW-IL attendees may even get to sit together in the gallery and be recognized by the Speaker! #### Illinois Legislation - 2019 Update

Jenni Purdue of J & J Legislative, LLC will be speaking at AAUW-IL State Convention on Saturday afternoon. During her brief presentation, Jenni will provide us an update on happenings at the Capitol and will provide more details on Springfield Day.

Jenni is again serving as our consultant for AAUW's "bills of interest." Newly-filed bills await assignment to a committee for a hearing prior to action on the floor of the House and Senate. Jenni confers with legislators, their staff, and other lobbyists/consultants with similar interests. She monitors the movement of bills through the legislative process and provides advice for action that we can take to seek support or opposition for our bills of interest. The public policy staff at the national office continue to provide oversight and technical advice for action alerts on both national and state issues. The alerts for contacting legislators for our bills of interest are emailed to members via the AAUW-IL Public Policy Google Group, who then share with members of the branches. Depending on the urgency of the issue, we encourage members to fill out witness slips, contact their legislators, or write letters to the editor of their local newspaper. We've recruited the passionate and energetic Faye Marcus to help communicate urgent issues. We appreciate AAUW-IL members who advocate for public policy!

#### Two bills that AAUW-IL members can advocate for are:

HB 2495 establishes the fundamental right to reproductive health which includes right to use/refuse contraception and the right to continue a pregnancy and give birth or have an abortion. It modernizes Illinois' reproductive rights laws by repealing outdated and unconstitutional prohibitions on reproductive healthcare and enacting a new Illinois Reproductive Health Act that regulates abortion like any other form of health care.

SB 1594 repeals the Illinois Parental Notice of Abortion Act, which requires a healthcare provider to notify an adult family member (parent, legal guardian, grandparent, or stepparent living in the household) at least 48 hours prior to performing an abortion for a patient under 18. The Act allows for a judicial bypass for those who cannot notify an adult family member. Decades of research and experience demonstrate that laws like this hurt young people and serve no valid purpose. The bypass process serves no purpose. Since the Illinois law went into effect in 2013, more than 99.5 percent of the judicial bypass requests throughout the state have been granted, because judges believed the minors were mature enough to make this decision independently, in consultation with their health care providers.


# Other State News: Governor Pritzker has signed key executive orders that support women's rights and equity

**No Salary Executive Order** - Requires that the Department of Central Management Services and the Department of Human Rights shall review the state's pay plan to eliminate bias generated by asking employees for salary history, which often disadvantages women, particularly women of color. The State of Illinois will no longer ask prospective employees questions about salary history, because of historic salary disadvantages women face. "As the sponsor of the no salary history bill, I am proud to stand with our new governor today as he takes strong, immediate action to close the gender pay gap and move towards pay equity," **said Rep. Anna Moeller.** "Governor Pritzker is making it clear to women across our state that they have a staunch ally and advocate in the governor's office."

**Full Enforcement of HB40 Executive Order** - "On the anniversary of Roe v. Wade, I'm proud to declare under my administration, the State of Illinois will be the most progressive state in the nation when it comes to guaranteeing the right to choose for every single woman," **said Governor JB Pritzker.** "Thanks to the courageous advocates across our state, HB 40 is the law of the land. I was proud to stand with you in that fight, because a right is only a right if it can be exercised by everyone. And today, I'm proud to sign an executive order that will further protect and expand the right to choose in Illinois - and that will fully implement all the provisions of HB 40." "Women's rights are human rights. It's important that women have the right and ability to choose what is best for them and their bodies," **said Lieutenant Governor Juliana Stratton.** "Today's executive order makes it clear that our state is a leader in that respect."

#### **AAUW-IL Advocates for Title IX**

In January, AAUW-IL, along with several other states, authored a letter to US Department of Education Secretary Betsy DeVos, urging her to withdraw the *Notice of Proposed Rulemaking on Title IX*. We encouraged her to work to ensure that schools protect students from sex discrimination by fully enforcing, not rolling back, Title IX's protections.


