2019 AGENT OF CHANGE

PAULA PURDUE



Paula Purdue was honored as our 2019 Agent of Change recipient at our State Convention.

Paula Purdue has been a member of AAUW since 1983 and has seen many changes and advancements for women as well as attempts to erode women’s rights. Paula, raised in a conservative family in Southern Illinois, received her Bachelor’s degree in education from Illinois State University in 1969, her Master’s degree from Michigan State and her second Master’s in Political Science from U of I in Springfield in 2007.

After a short teaching career, she became the state lobbyist for the Illinois Education Association—a job she held for 28 years. As an educator, many of the bills she supported were also of importance to AAUW. In June of 1983, Peg Breslin from Ottawa, introduced a bill that required math and science to be taught in Illinois high schools for all four years. It was discovered some schools did not have one science or math class for any high school grade level. The bill was passed and Paula was instrumental in lobbying for its passage.

After leaving the IEA she started her own firm and served as AAUW’s lobbyist. Through the years passage of the ERA has been on her mind. Distressed that this did not pass in Illinois when it was first proposed in 1972-1973, Paula began lobbying for passage in 1976. Forty some years later, and officially retired as a lobbyist, she was still working to pass ERA in Illinois. In anticipation of action on this piece of legislation, Paula stayed in Springfield for weeks lobbying and ever so slowly working for the needed votes. The Amendment passed in May of 2018—certainly a result of pressure from many quarters but none more dedicated than Paula.

Her efforts and other AAUW Illinois members were recognized by the Illinois **Women’s Institute for Leadership** after the passage of ERA in Illinois.

In 2012 Paula retired for a second time and moved to Chicago, where she has mentored the next generation of women influencers. It was during this period that Paula, in cooperation with the Chicago, Inc. Branch, presented PUBLIC POLICY 101 in Chicago and at our State Convention.

Perhaps as important as her career and dedication to causes that are near and dear to AAUW, is her reputation for integrity, thoroughness and knowledge among the public policy supporters in the membership.

We congratulate Paula on being our Agent of Change 2019.

History of the Agent of Change Award

The Agent of Change Award was instituted in 1984 by the Board of Directors of the Illinois State Division, now AAUW-IL, Inc. This prestigious award is presented annually to an AAUW member who has served as a catalyst to bring about positive societal change and visibility to AAUW. The five District Directors are charged with selecting the Awardee from nominations submitted by AAUW-IL branches.

All efforts that relate to AAUW's mission will be considered, with special emphasis placed on activities that relate to current AAUW priorities and initiatives. For example, individuals who have actively promoted change in the areas of education, equity, advocacy, and/or public policy, and have brought visibility to AAUW, should be among those considered as nominees for this prestigious award.

The Agent of Change Selection Committee chose to honor Paula Purdue for her work on getting the Equal Rights Amendment passed in Illinois with the 2019 award. The committee wishes to thank Carol Heisler of the Crystal Lake Branch for nominating her. Paula was named the 2019 Agent of Change at the AAUW-Illinois State Convention on May 4, 2019.

2020 AGENT OF CHANGE AWARD

The process for selecting our next recipient for this prestigious award will begin in January 2020. Branch presidents will receive a packet with instructions, criteria, nomination forms, and a list of past winners. The deadline for nominations will be March 1, 2020. Conversations regarding possible candidates should not be delayed. Nominees should be outstanding models who have actively promoted change in education, equity, diversity, and/or public policy. The nominee's accomplishments should show direct involvement with the member's branch and/or other AAUW national initiatives.

This award emphasizes promotion of AAUW's mission and purpose as well as bringing visibility to AAUW.

- Nominations may come from individual members or branch boards.
- Current AAUW board members may be nominated.
- There is no longer a "during the past year" requirement for accomplishments.
- Individual members or branch boards may resubmit previously-nominated individuals.



TRIO Program **RETURNING FOR 2019-2020**

Members who have never attended a State or National Convention are eligible. Stipend recipients will be paired with mentors to make sure they get the most out of the Convention experience.

WHAT?

The TRIO program is a stipend to be used as an incentive for first-time attendees to the AAUW-IL State Convention (at the multi-state convention) in June 2020 in East Moline.

WHERE? WHEN?

The State Convention will be held concurrently with the multi-state convention (June 18-19 at the Hyatt in East Moline, IL)

WHY?

The State Board feels that attending conventions is a great way for members to feel connected to AAUW and to the AAUW mission.


HOW?

Branches may designate one first-time attendee; the State agrees to pay the registration fee (estimated at 1/3 of the total convention expense) with the suggestion that the branch pledge to pay 1/3 and the member pay the remaining 1/3. The designated applicant will indicate on the convention registration form found in the Spring LINK Newsletter that she is using TRIO. Stipend recipients will be paired with experienced AAUW members who will share all the convention details. Further details and registration information will be provided in the Spring LINK.

That being said, there are ways you can stay engaged while they are not in Springfield, and back home in their districts. 1. Do you know who your IL State Senator is? Or your IL State Representative? If not, do a simple Google search and find out. Ask your yearbook editor to include the information of your branch’s legislators in your branch yearbook. 2. Sign up for their newsletters and follow their social media. 3. Attend town hall meetings they are holding. (these meetings are usually announced on their Facebook pages or in their newsletters.) I know that my representative and neighboring districts have held community meetings on the opioid crisis, environmental panels, and gun issue meetings this summer.
