## **Conference Speakers**



**Deanie Brown** is an attorney living in Springfield, Illinois, where she serves as the Chief Diversity and Inclusion Officer for the Illinois Supreme Court and the entire Judicial Branch. She has been associate chancellor, chief of staff, and director of human resources and internal relations at universities in Chicago, Champaign, California, and New Orleans, and serves on several boards supporting equity, education, the community, and the arts.

Deanie's areas of expertise include nondiscrimination law, Title IX and sexual misconduct prevention and response, disabilities accommodations, and culturally competent conflict resolution. She earned a bachelor's degree with honors in the history of architecture and art from the University of Illinois at Chicago and her law degree from the University of Illinois at Urbana-Champaign, where she taught Rhetoric and Writing and was also coordinator of the Writer's Workshop at the African American Cultural Center. In addition to her law-related work in higher education, Deanie was a law clerk at a small firm in Chicago and at the Department of Labor in Washington, D.C.

Deanie is currently director of diversity, equity, and inclusion for the AAUW Springfield Branch, and has also served as college and university relations director for the Branch and AAUW Illinois, and as 2018-2020 co-president of the Branch.



**Kristin Olson** began writing grants when she was a graduate student at the University of Illinois Springfield. After earning her master's degree in nonprofit organization management, she worked in the nonprofit sector for seven years. Kristin provides comprehensive grant writing services through her consulting firm, GrantsGalore, which she established in 2006. She has submitted nearly 600 grant proposals and, with a success rate of 55%, has secured \$174 million in grant funding and government contracts for U. S. nonprofit organizations and units of local government.

Kristin is a former member of the Springfield Branch of AAUW, serving as Expanding Your Horizons Registrar from 2014-2017.

# 2021 AGENT OF CHANGE JOY BOWLING

Joy Bowling of the Aurora Area Branch was honored as the AAUW-IL 2021 Agent of Change recipient at our 2021 (virtual version) 96th State Convention for her 40+ years as a voter registrar, but most specifically for registering 67 voters in 2020 during a pandemic.

Before the Covid-19 pandemic, Joy could be found registering voters at candidate forums, several area churches and even at the MLK Jr Tribute at the Chicago Sinfonietta.

After the pandemic hit, she continued her work. Joy passed out QR code cards so people could register on their smart phones while they were waiting in lines at the food pantry. She registered 4 physical therapy assistants while at her doctor's appointment, as well as 5 dental assistants while at the dentist. Her proudest moment was registering 7 women at the Lifespring Center, where they offer safe shelter for women and children that have lost their housing due to addiction, abuse or financial crisis.

Joy also partnered with the Quad County Urban League and conducted two voter registrar classes that resulted in 10 African American new voter registrars.

She also participated in GOTV initiatives that included postcard writing campaigns and made 500 phone calls to GOTV.

Per the AAUW website "increasing voter turnout was a priority for the 2020 election. The more people who vote, the better our representative democracy will function." Joy's work of inspiring voters and connecting with activists helped get our country's first woman of color elected as Vice President along with changing the administration that was going in the direction that did not support equity for all.

#### AAUW Public Policy During a Pandemic (still...) September 2021

2020-2021 was a strange year for the Illinois legislature. The Illinois legislators met for committees using zoom most of the time. At the end of the legislative session in May, our lobbyist could go into the Capitol IF she took a test 2 days before she wanted to go into the Capitol. The test had to come back negative and then the third day she could enter the Capitol IF a legislator asked her in. Not being able to be in the Capitol and the legislative offices really cramps a lobbyist's ability to contact legislators. Hopefully next year will be more normal but at this time we don't know.

On August 16th, Emily Deakin-Harmony from the Commission on Government Forecasting and Accountability (CGFA) at the Illinois General Assembly facilitated a training on how to navigate the ILGA.gov website. There were 25 attendees that included public policy chairs and AAUW members, along with a few members from coalitions we work with on public policy. Emily was thorough, kind and an excellent teacher. We all learned more about the web site that shares all that happens in the Illinois legislature. Jo-An Takamoto Sabonjian made the connections with Emily and all attendees learned and enjoyed. We may need to do this every couple of years to bring new folks up-to-date and to help some of us seasoned members remember what we have learned. In June we wrapped up a busy and productive legislative session. Here is an update:

Ensuring Success in Schools Law HB 3223 passed. This requires appropriate, trauma-informed responses to the needs of every student.

Keeping Youth Safe and Healthy Act SB 818 passed. This updates the curriculum in schools (that choose to teach Health and Safety education) to be age appropriate, medically accurate, all inclusive, culturally appropriate, and trauma informed.

HB 155 passed. This allows SNAP, WIC, and TANF recipients to use their benefits to purchase menstrual hygiene products and diapers.

HB 641 passed. This requires that public universities and community colleges make feminine hygiene products available at no cost in bathrooms.

HB 156 passed. This provides that menstrual hygiene products shall be made available in bathrooms of every school building that are open for student use in grades 4 through 12 during the regular school day.

HB 310 passed. Provides that feminine hygiene products be available free of charge at all homeless shelters that provide temporary housing assistance to women or youth.

Equal Pay Day Resolution HR 220 passed.

Repeal of Parental Notice of Abortion HB 1797 did not come up for vote in this session.

HB 012 passed. Provides that an employee of a school district, public university, or community college district who has been employed for at least 12 months and who has worked at least 1,000 hours in the previous 12-month period shall be eligible for family and medical leave under the same terms and conditions as leave provided to eligible employees under the federal Family and Medical Leave Act of 1993.

HB 816 passed. Amends the Employment of Teachers article of the School Code - provides that, in addition to birth, adoption, or placement for adoption, sick leave shall also be interpreted to mean the acceptance of a child in need of foster care.

The Family and Medical Leave Insurance Act (SB 835) creates a state-run insurance program that allows Illinois workers to use 26 weeks of job-protected leave a year to welcome a new child into the home, to maintain a healthy pregnancy, for their own family member's illness, for reasons related to domestic or sexual violence, and for reasons related to military. This bill was developed last year with several of AAUW Naperville's members on the committee to get this bill ready to draft. AAUW Illinois will be working to pass this bill next year. WE NEED AAUW MEMBERS TO CALL THEIR SENATOR AND ENCOURAGE THEM TO CO-SPONSOR SB 835. Please share the information as well with your representatives, but the bill will need to pass the Senate first. Unfortunately, this is not a paid leave but that will be step 2. One of the reasons that women are not paid equally is that women end up doing all of these jobs listed above but can't regain their jobs afterwards. This bill is for women and men. We are excited to be a part of such an important issue for our members today and in the future. If you are a member of other organizations, ask them if they would like to support it as well.

We were not able to pass every bill that was on our important bill list but we made great progress forward in a very difficult legislative year. We appreciate everyone's support of our public policy and thank all of you who have participated to move our issues forward.

- Governance have a branch operations plan that aligns with AAUW national priorities; create a succession plan for branch leadership; add a Diversity and Inclusion chair on your board
- Programs hold at least four mission-based programs, including Diversity/Equity/Inclusion; and collaborate with another branch
- Communications keep your branch website and social media up-to-date (cross-post content from your branch newsletter)

Last year four branches were recognized for three, four, and five stars. AAUW-Illinois is reaching for ten branches to achieve that status. We can do it! The stars are within our grasp.
