Public Policy

AAUW continues to fight policy changes at the federal level that negatively impact education. They signed on to a coalition letter urging Congress to oppose policy riders that are anti-diversity, equity, inclusion, accessibility and anti-critical race theory in the fiscal year 2026 Appropriations Bill. You can read the letter here LDF-Et-Al.-Coalition-Letter-Opposing-Anti-DEIA-Riders.pdf AAUW has also signed on to another letter urging the U.S. House Committee on Appropriations to eliminate the Hyde Amendment in the fiscal year 2026 appropriations to reduce barriers to abortion care. FY26 Letter to Congress - Eliminate Hyde Amendment. Access to reproductive health care is of great importance to young women and their ability to achieve educational goals.

As the state legislature will not be in session again until October, we encourage our members to look for their legislators at community events and town halls. Let them know what issues are important to you. These kinds of casual conversations can be just as impactful as a scheduled visit to a senator or representative's office. Good news often seems hard to come by in the political arena, so we wanted to share the news that a federal judge on Thursday (August 14th) struck down two Trump administration actions aimed at eliminating diversity, equity and inclusion programs at the nation's schools and universities.

Yesterday, a federal judge delivered a major legal victory for public education and civil rights. In American Federation of Teachers et al. v. U.S. Department of Education et al., the court struck down the Trump—Vance administration's attempt to force schools nationwide to censor lessons, eliminate diversity and inclusion programs, and sign unlawful compliance certifications under threat of losing federal funding and facing criminal penalties.

Judge Stephanie A. Gallagher ruled that both the administration's February 14 "Dear Colleague Letter" and its mandatory certification violated the Constitution and the Administrative Procedures Act, stating: "Plaintiffs have shown that neither challenged agency action was promulgated in accordance with the procedural requirements of the APA, and that both actions run afoul of important constitutional rights."

This decision vacates both policies, protecting the ability of educators to teach honest history, support students, and foster inclusive learning environments.

In March, AAUW joined a <u>coalition letter to the Department of Education</u> urging the rescission of the February 14, 2025, "Dear Colleague" letter. In April, we joined a letter to Elementary and Secondary

As you may know from our updates at branch meetings, four of our branch members, Rosie McVay, Maureen Brandon, Chris Bruun and Pat Hendrix, have been working tirelessly over the past year to spread the word about the Dignity Index. They kicked off this training effort at the AAUW-IL state convention in April of 2024, and since then this mighty team of leaders has introduced the Dignity Index to AAUW members in 7 branches, including ours (and one more is planned for next week), and several sister organizations like the League of Women Voters. In total, we estimate that more than 250 (and counting!) people have been trained.

Well, as you can imagine, this kind of incredible work has drawn the attention of UNITE, the organization formed in 2018 to find ways to help ease divisions in the country and the one that developed the Dignity Index. So, we are excited to share that the great work supported by Rosie, Maureen, Chris and Pat of our Branch has been recognized in a Dignity Index website news article. It even includes a photo of our branch attendees at last year's state conference, in addition to one of the Dignity Index training team. 


