Sarah Labadie is an expert in a wide range of issues, such as paid leave, postsecondary education and training, fair wages and schedules, and pay equity. A member of the Women Employed staff since 2008, Sarah collaborates with various stakeholders to advance and effectively implement laws and regulations at the local, state, and federal levels, thus improving the economic status of women and removing barriers to economic equity. Sarah has launched and managed several coalitions, including the Illinois Paid Sick Days Coalition, the Illinois Time to Care Coalition, and the Illinois Higher Education Network. In 2023, she successfully passed the



Illinois Paid Leave for All Workers Act, which guaranteed short-term paid time off to workers across the state. She is also spearheading the legislative campaign to create a long-term paid family and medical leave program in Illinois.

This program is organized by Karen Kortsch, our AAUW-IL State Public Policy Co-Director, and hosted by the Jane Addams Branch.

It seems there are major events on the political front every day. At times they seem at odds with each other. It is more important than ever that we stay informed, speak out and take action in support of the <u>AAUW strategic goals</u> to "empower women and girls by championing their success in higher education and pushing for policy solutions to create lasting change."

both passed versions of the budget, but they need to be reconciled with the same version passed by each house. The Senate version rejected many cuts to education desired by the administration, while the House generally followed the administration's wishes.

On the rulemaking front rules are expected in the Departments of Education, Energy, Veteran's Affairs and Labor that impact opportunities for women. The volume of responses to proposed rules can make a difference, so expect to be asked to comment. Currently the U.S. Department of Labor is moving to roll back anti-discrimination protections, leaving the nation's 36 million federal contract workers—nearly one in five U.S. workers, many of them women and people of color—vulnerable to discrimination. Two New AAUW Funds 2025

Plan to donate to AAUW Funds from September through December 2025. In the past years, you have been encouraged to donate to the **Greatest Needs Fund #9110** because this fund allows AAUW to address current issues very quickly since the fund is unrestricted. In 2024, National received many requests from AAUW members to have more specific ways to address current issues through giving. National listened and decided that there should be two new funds that are a little more specific and would allow National to address emerging issues but especially those related to the AAUW Strategic Plan 2025-2027

One new fund is the **Defend Higher Education Fund #4513**. This fund will enable AAUW to elevate the critical higher education issues impacting women. It will also provide strategic resources to students, staff and faculty on campuses and fuel investment in infrastructure and technology necessary to move AAUW's mission forward. Donations to this fund ensure AAUW can effectively fight on behalf of women on campuses across the country.

The **Public Policy Fund #4337** is the other new fund. This fund will enable AAUW to take action to oppose all forms of discrimination, for example, discrimination on the basis of age, disability, race, ethnicity, sex and gender, etc. This fund will also enable AAUW to invest in strong public education, inclusive curriculum and STEM opportunities. Other areas that this fund will support are economic security for women and the reinstatement of Title IX rules.

Donations to any of the three funds discussed above will count toward the total AAUW Funds given by your branch in 2025. Remember that for every \$500 your branch donates, AAUW-IL provides branches the opportunity to present a Branch Named Honoree Certificate to a branch member who has made special contributions to your branch in 2025.


